PHRC "SPARKLE" STAKES

PEE WEE STAKE - Geared for puppies 3 - 6 months but any dog is welcome to participate. Puppies complete one short land retrieve and two short water retrieves to a designated area. Delivery to hand is not required. Handler's choice of ducks, bumpers or dokkens. **LOTS** of encouragement is allowed!!!

VETERAN STAKE - Open to all dogs 8 years and over. <u>Set up is handler's choice</u>! Bring your veterans out to strut their stuff and have a good time!!

A Rosette will be presented to all PEE WEE and VETERAN participants

PHRC CLUB TEST REQUIREMENTS PHRC – Club WC/I/X All Other Retrievers

WC - Dogs must complete one land retrieve and two water retrieves to a designated area. Delivery to hand not required.

WCI - Dogs must come to the line off lead, must complete a land and a water double. Delivery to hand, not gun shy and on-lead honor is required. Decoys and boats may be used.

WCX - Dogs must come to the line off lead and complete a triple on land, a water double, land and water blinds and an off lead honor. A diversion may be used. Decoys and boats may be used.

PHRC Rosettes will be awarded to all WC/I/X qualifiers!
